The financial statements of The Diocese of Western Kansas at September 30, 2021 are for the period January 1, 2021 through September 30, 2021 and are unaudited. The assessment income represents income received for the period January 1, 2021 through September 30, 2021 and reflects September assessments received through October 12, 2021. Expenses incurred are for the period January 1, 2021 through September 30, 2021. The financial statements that will appear in the 2021 Journal of the Diocese will be audited as of October 15, 2022.

The audited assets and liabilities of the Endowment Fund represent balances as of December 31, 2020. The audited Endowment Fund statement of assets, liabilities and fund balances are incorporated into the financial statement of the Diocese of Western Kansas at year end and will appear in the 2020 Journal of the Diocese of Western Kansas.

STANDING COMMITTEE REPORT

The Standing Committee Serves as the Bishop's Council of Advice, and acts in matters such as recognizing new missions and missions becoming parishes, consenting to alienation or hypothecation of congregational or institutional property, consulting upon differences between a rector and vestry, approving the progress of individuals through the process for ordination to the diaconate or priesthood, approving the release and removal of individuals from the ordained ministry, consenting to the deconsecrating of churches, and, consenting, along with other standing committees (consent of a majority of standing committees being required), to the election of bishops of other dioceses or filling a vacancy in the office of presiding bishop; Serves as Ecclesiastical Authority for the exercise of specified episcopal functions when no bishop is authorized to act by reason of vacancy in office, and acts according to the Constitution and Canons of The Episcopal Church.

During the past year the Standing Committee has faithfully carried out its mission despite the inconveniences of the Covid Pandemic. We met in person when we could, but most of the business was conducted via zoom meetings.

We joy to see the Diocese continue to move according to the direction of the Holy Spirit, especially in the raising up of new people called to the ordained ministry, namely, Andy Houltberg Todd Ray, Shane Schneider, Scott Mentzer, and Pat Schiefen. Currently there are people in Dodge City, Hays and Liberal in the discernment process. A remote BKSM learning and formation group, similar to the one we had last year in Garden City, is being established in Dodge City, under the guidance of The Rev. Canon JJ Bernal.

We also joy in the continuing financial health of our diocese. Surely God has a plan for us.

We were deeply saddened by the loss of Mary Hixson. David Hodges was appointed to take her place on the Committee.

As a part of the whole Episcopal Church, we assisted in approving the elections of the following Diocesan bishops: Ketlan A Solak, Pittsburgh, Paul-Gordon Chandler of Wyoming, and Betsey Monnot of Iowa. Some of the routine business conducted included approving a temporary easement for Holy Nativity in Kinsley, completion of the sale of St. John's to St. Francis, and approval for the sale of Grace Church in Anthony. As we continue to move forward as a Diocese, we know that, in the words of Dame Julian, "all shall be well, and all shall be well, and all manner of things shall be well." Respectfully submitted,

COMMISSION ON MINISTRY

The Canons of the Episcopal Church direct that the Commission on Ministry shall advise and assist the Bishop in:

- (a) The implementation of the Title III Canons of the Episcopal Church.
- (b) In the determination of present and future opportunities and needs for the ministry of all baptized persons.
- (c) In the design and oversight of the ongoing process for recruitment, discernment, formation for ministry, and assessment of readiness therefor.

The Commission is composed of the following diocesan clergy and laypersons: The , The Rev. Amy Long (Hutchinson), The Rev. Carolyn Ballinger (Mother Carolyn has now moved to the Navajoland Area Mission), The Rev Mary Hisson (Mary died from complications of COVID 19 in November of 2020), Mother Mary was replaced by the Very Rev. David Hodges (Cathedral), The Rev Cn. J.J. Bernal (Dodge City); Mrs., Jackie Mitchell (Liberal), Mrs. Carolyn Peterson (Salina), and Bob & Margie Prewitt (Garden City).

Dean Hodges, Mother Amy, Jacki Mitchell and Carolyn Peterson will be rotating off the COM as of the Diocesan Convention and we thank them for their dedicated and loyal service to our Church and the Diocese.

Since the Diocesan Convention of 2020, the Commission on Ministry (as the end of August) the COM has met five (5) times (Several meetings were virtual due to COVID restrictions).

Meetings:

October 24, 2020: Commission met via Zoom. We interviewed 5 Postulants who were applying for advancement to Candidacy level in the process: Interviewed were: Julie Meier of Ulysses; Pat Schiefen of Goodland; Scott Mentzer of Goodland; Todd Ray of Hutchinson, and Andy Houltberg of Salina. All were recommended to Bishop Cowell for advancement to Candidacy.

February 13, 2021: Commission met via Zoom. We reviewed Andy Houltberg's application for ordination to the Sacred Order of Deacons. COM recommended ordination to Bishop Cowell. With the approval of the Standing Committee and the Bishop, Andy was ordained a Deacon on March 20, 2021, in Christ Cathedral.

May 8, 2021: Commission met via Zoom to review the application for Ordination of Todd Ray to the Sacred Order of Deacons. COM recommended ordination to Bishop Cowell. With the approval of the Standing Committee and the Bishop, Todd was ordained a Deacon on June 19, 2021, in Grace Church, Hutchinson.

July 24, 2021: Commission met at St. Michael's in Hays. We interviewed Scott Mentzer and Pat Schiefen who were applying for ordination to the Sacred Order of Deacons. COM recommended ordination to Bishop Cowell. With the approval of the Standing Committee and the Bishop, Pat and Scott will ordained Deacons at the opening Eucharist of the Diocesan Convention in October 2021.

Commission also interviewed, and recommended Shane Schneider's application for advancement to Candidate level.

August 21, 2021: The COM met at St. Cornelius Church in Dodge City to interview 3 Aspirants seeking Postulancy: Reynold Hamilton (Liberal); Sandra Herder (Dodge City); and Perry Harrison (Hays). The COM recommended all 3 Aspirants to the Bishop for admission as Postulants.

In other news: BKSM West continues to function, however this year we have moved to Dodge City where we have several distance students.

Further, an alternative path to ordination is being tried at the request of Bishop Cowell. This is a "Reading for Orders" program, and is currently in the "experimental stage" with two students in Hays who are being mentored by Mother Shay Craig, and the Bishops.

TREASURERS REPORT

The Ad Hoc Budget Committee met in the Diocesan offices, reviewed our financial reports for recent years. These reports are not the "normal numbers" that we would expect to see due to the Covid Virus situation during the last 18 to 24 months requiring a drastic change in the way our Churches have had to operate. Fortunately, the income side has stayed relatively stable, for which I wish to congratulate everyone for keeping up with their assessment payments as well as you have. The expense side of the report has changed in some areas for the same reasons. The Committee developed a budget with these things in mind. Our proposed budget is printed in your convention papers and has been approved by the Diocesan Council as required by the Canons of the Diocese. I would like to thank Bishop Cowell, Mrs. Pam Smith, and Mrs. Carolyn Peterson for their agreeing to assist in this matter, with a BIG THANKS to Mrs. Toni Cottrell who lays the groundwork for the Committee.

ENDOWMENT FUND TRUSTEES' REPORT

The Endowment investments had another big gain last year, gaining \$1,086,944 or 23% on invested assets. The S & P 500 gained 18% by comparison. Eight of the twelve securities we owned had double digit returns. No changes were made in the portfolio last year. The investment gain for the year was allocated proportionally among 27 funds based on last year's average monthly balance for each.

In addition to the investment performance, \$399,136 in in new funds were received by the Endowment last year. Support for the Diocese has been made possible by many donors over the past 36 years, but by far the largest single donation (other than the stock market's gifts) was by Donna and Jack Vanier of Salina, who gave the Endowment \$542,000 in 2005. This single Undesignated donation has produced nearly half of the annual Endowment support for the operation of the Diocese.

Endowed Funds were given to the Endowment with the intent that the original gift would be preserved and only investment earnings be used by the beneficiaries. In this way, the gift could "keep on giving" forever. But if all investment earnings were distributed annually, only the original gifts would remain and inflation would eventually erode the value of these gifts. So, we accumulate investment earnings (and losses) in Temporarily Restricted accounts. Then we calculate five percent of the average of the most recent three years' Original Contributions and Temporarily Restricted fund balances for each Endowed Fund as the amount of new money to make available to the beneficiaries. The 5% is then transferred annually to its corresponding Spendable Fund. Any investment earnings over the 5% transferred are accumulated in the Temporarily Restricted Accumulated Earnings accounts. This year, \$125,107 of new Spendable money was made available for use by the Diocese and other beneficiaries. The total Spendable money (including \$710,475 of unspent funds from prior years) is now \$835,582.

(Endowment Report contd.)

The Endowment distributed \$90,000 to the Diocese, \$3,098 to Grace Church Anthony, \$10,000 from the Incarnation Salina Fund for the Montessori School at Christ Cathedral, \$7,700 to St. Marks Medicine Lodge, \$35,000 for the St. Michaels Ministry Hays and \$6,000 to St. Thomas Garden City.

Managed Funds may be withdrawn in part or in total by the depositor. Partial withdrawals are permitted upon the request of the depositor or on a regularly scheduled monthly or quarterly basis. Withdrawals of entire Managed Fund balances may be made with at least 30 days' written notice to the Trustees.

Council Restricted Funds may be withdrawn by the Diocese, subject to these guidelines:

- The Future Ministry Epiphany Grant Funds balance is \$250,430 and is to be used at the discretion of the Bishop and Council.
- The Future Ministry Opportunity Funds balance is \$757,168 and is to be used at the discretion of the Bishop and Council.
- The Lambeth Fund balance is \$18,359 and is to be used to help fund the Bishop's travel expenses to the Lambeth Conference.
- The Standing Committee Fund balance is \$4,919 and is to be used at the discretion of the Bishop and Council.

CANON THEOLOGIAN REPORT

Locked down this past year continued to severely restrict my normal travel for teaching and preaching until May 2021. However, being confined mostly to Berlin had its bright spots. I was able to attend more of the regular diocesan weekly Zoom Bible studies and discussions. I also was able to finish several writing projects:

When travel began to return in May 2021, I continued my visits to North Africa as the Chairman of the Board of Governors of the Alexandria School of Theology Education System. I attended the retirement of the previous Anglican Primate of Alexandria and the installation of his successor (June 2021), was the Graduation Speaker for St. Athanasius Provincial Seminary in Cairo (August 2021), was a speaker at a conference for church-planters in Tunisia (September 2021) and attended the inauguration of the Province by the Archbishop of Canterbury (October 2021).

In my ministry to athletes, I was the resident Pastoral Counselor for the International Swimming League during its "bubble" season in Budapest (October-November 2020). I attended the Olympic Trials for Swimming in Omaha (June 2021) and provide pastoral support to athletes in Tokyo electronically during the Covid-restricted Olympic Games (July-August 2021). Furthermore, I designed and have begun to implement regular emotional wellness training for the Youth Academy of Hertha BSC, the professional soccer club in Berlin. This program is first of its kind not only in Germany but throughout the global world of professional soccer.

Finally, closer to home in Western Kansas, I gave a lecture on the theology of Thomas Cranmer for the Bishop Kemper School for Ministry (October 2021). I also found a home for historic personal items belonging to James

Gardiner, the father-in-law of our Bishop Shirley Nichols, who was a famous missionary architect to Japan and the first President of St. Paul's University in Tokyo. Now called Rikkyo University, its museum will be the final home for Mr. Gardiner's diamond-encrusted gold cigarette case, presented to him by the Russian Imperial Household in 1915, and his gold-topped walking cane.

I plan to serve as a Chaplain again at the World Swimming Championships in May 2022 which will be back in Japan. As part of that trip, I will, on behalf of Western Kansas, present to the Diocese of Kyoto its copy of the 1928 Standard Book of Common Prayer kept safe for them by the Cathedral in Salina. I will also present Mr. Gardiner's cigarette case and cane to Rikkyo University.
