MINUTES OF THE 47th ANNUAL CONVENTION EPISCOPAL DIOCESE OF WESTERN KANSAS OCTOBER 20 & 21, 2017

Thursday, October 19th

Delegates and guests who arrived the night before Convention were served a good meal in the Parish Hall at St. Anne's Church in McPherson. Everyone enjoyed the meal and a pleasant evening renewing acquaintances and greeting friends.

Friday Morning October 20th

Convention activities began at 9:00AM at the McPherson Museum, McPherson, Kansas. Displays from congregations and organizations representing Women's ministries including United Thank Offering, Diocesan ECW, and Daughters of the King; Dodge City youth group; Bishop Kemper School for Ministry; St. Francis Community Services were visited by delegates, alternates and guests as they enjoyed coffee and cookies. Registration continued in the lobby of the Museum.

Opening Eucharist

At 10:00 AM the Festival Eucharist was celebrated at St. Anne's Church. Clergy processed to congregational singing of "Come Thou Almighty King". The Rt. Rev. Michael Milliken presided and preached. The Rev. Carolyn Ballinger gave the necrology report. At the offertory, the United Thank Offering ingathering was presented by representatives from the various congregations.

Dispatch of Business Chair Carolyn Peterson moved that the 1st and 2nd report of the Resolutions Committee be moved to the first legislative session; That offerings from the Convention Worship services will be used to support Biblically based ministries in the Diocese, that this Convention send greetings to The Rt. Rev. and Mrs. Vernon Strickland and The Rt. Rev and Mrs. James M. Adams, Jr., and that any special order of business may be adopted by a two-thirds vote of the voting members present at this convention, providing there is a quorum of the House present. So moved and Adopted.

NEW DIOCESAN CLERGY

Bishop Milliken recognized new clergy to the Diocese -The Rev. Jeff Mitchell, Liberal and The Rev. David Hodges, St. Francis Foundation and Provost of Christ Cathedral. He also recognized The Rev. George Martin, Lyons. The Rev. Katie Hargis has been called to the pro-cathedral in Hastings, NE.

RESOLUTIONS COMMITTEE REPORT

The Rev. Dennis Gilhousen announced there is only one resolution to be included in this Convention, and asked the member of the Resolutions Committee, Georgia Briery, to read the resolution as follows:

The Rev. Dennis Gilhousen moved Convention suspend the rules of the house for the adoption of the above Resolution. It was seconded and after debate and explanation by the Chancellor, the vote was PASSED.

BUDGET AND FINANCE COMMITTEE REPORT

Dr. Mike Wamsley presented the proposed budget for 2018 He reminded Convention that at this time, the presentation was for information only and not for discussion. Dr. Wamsley then recognized the Budget Committee members.

Dr. Wamsley then started through the 2018 Proposed Budget explaining only those items which will show an increase in the coming year, and gave a

description of the increase. General Church Program Pledge is established by the National Church and they tell us how much to pay; Diocesan Ministry Work is set by our Bishop, and since we had not used half of the current year's allotted amount, that budget item was cut in half; Retired Clergy Insurance Program will have an increase. Moving down the budget to Church Planting that budget item was decreased and further down, the Audit Expense was decreased. Leaving a proposed 2018 Budget of \$350,739.00.

Dr. Wamsley stated that the budget hearing would be held at the close of this First Legislative Session.

REPORTS

DIOCESAN YOUTH

Cathleen Cowell, youth representative from Sts. Mary and Martha Church in Larned and she introduced Vanessa Carlos, the youth representative from Dodge City Cathleen spoke about the EYE Convention this summer which was held at the University of Central Oklahoma in Edmond. They arrived on Monday and there were about 1300 youth in attendance. The mixer programs were outstanding. The group organized and found their lodging, etc., and the following day the youth were bussed to Oklahoma City to visit the Alfred P Murrah Bombing Site Memorial which was quite emotional for many of the young people attending. While in the City, they visited a Native American Museum and had a very long, enjoyable day.

The representatives stated they attended workshops on Tuesday and on Thursday, and the group from Western Kansas attended the Presiding Bishop's workshop on Thursday, where he explained what he did and he was a very cool guy, quite short! We also went to the UN delegate workshop and that was very interesting. While Cathleen attended the UN workshop on Thursday, Vanessa attended a workshop with youth from Palestine and Israel.

I would encourage you to challenge your youth to get involved and plan to attend the next EYE in 2020. Date and or place has not been selected, but it would be well worth the experience. Thank you Amy Long for taking us.

The Rev. Mark Cowell followed up the youth presentation and stated there will be a Happening taking place November 10-12, 2017 at Christ Cathedral in Salina. Encourage your youth to make every effort to go. The Happening registration application is on our website.

ST. FRANCIS COMMUNITY FOUNDATION

Bishop Milliken asked The Rev David Hodges, President, St. Francis Community Foundation to come to the front and speak because it is now worldwide and not contained in Kansas. The Rev. Hodges came forward and explained he was happy to be canonically resident in the Diocese of Western Kansas now, and St. Francis has been a part of this diocese for over 75 years, founded by Father Bob Mize and it has evolved and has become what is now St. Francis Community Services. Fortunately, over the years, it has become a national and international ministry. We have been working in four states for the last number of years and will soon be opening in Texas as well as El Salvador and Honduras.

The number of lives we touch is about 30,000 a year and we are working with children and families, providing for those in crisis and helping bring families back together and where that is not possible provide residential care for the children and treatment that will hopefully enable them to go on and live lives more hopeful than they are now. So, in the last couple of years we have become involved in providing treatment for young adolescent girls who are victims of human trafficking. We are hoping to expand that work not only here in our country but internationally. Most of all, we are committed to developing and reinforcing the relationship we feel we have with the Episcopal Church. We went through a very long period when we were not very good about doing that, and I, as President of the St. Francis Community Foundation, hope to work with the churches in this diocese as well as throughout the country.

Bishop Milliken said that he and Sherry Denton both have rotated off the Board of Directors at St. Francis this year, and they have been pleasantly surprised at the strides which have been made over the years. St. Francis is no longer a small organization in this state, but as The Rev. Hodges explained, they are involved in several states and now in Honduras and El Salvador, touching lives of hundreds and hundreds of people.

RETIRED CLERGY CHAPLAIN

The Rev. Jerry Jones spoke about his time as Chaplain for Retired Clergy in our diocese. He just met with Chaplains from Provinces V, VI and VII in Albuquerque, NM. Lots of new information will be out in 2018 for retired clergy. He stated he was amazed when the group was told that Church Pension Fund was set up in 1917 with \$6 million, and in 2018 the Fund is \$12 Billion! The CPF provides pensions for retired clergy and you can receive helpful information from their offices. If you have questions, please contact me and I will attempt to locate the proper party to assist you

BISHOP KEMPER SCHOOL FOR MINISTRY

Mrs. Casey Rohleder, a third-year student and part-time marketing director for Bishop Kemper School for Ministry (BKSM), reported that the school has formed a new partnership with the Evangelical Lutheran Church in America (ELCA). Pastoral Ministry Associates from the ELCA will receive training at BKSM.

She also reported that the school will be expanding its offerings from training only candidates for ordained ministry to focus on lay ministry as well. She stated that classes are offered once a month beginning at I:00 PM on Saturday and continuing through Sunday. Cost is \$100 for the weekend.

CAMP RUN-A-MUCK

The Bishop reported Jason Lamb is now the Russell Springs Fire Chief, then he turned the mic over to Molly Lamb who gave an introduction to the Camp which is located outside Russell Springs (17 miles!). Molly explained that about five years ago, she and her good friend Rebecca felt called to work with at risk kids, and this is their fifth year. They run two week- long camps each summer for teenage girls from St. Francis Community Services.

The primary focus of course is ministry to the girls to develop a relationship with our Lord and Savior, Jesus Christ. We have Bible study, we have praise and worship time, and campfire ministry. We also use horses for horseback riding. I work with the horses and I also do art therapy. Rebecca's primary focus is ministry, but we do work together. We do not charge the girls to come to camp, but they do have daily chores which teaches responsibility and they have 100% responsibility for the horses as well. She explained she could certainly see a difference in the girls as they left camp after a week and it was all a service these two women could provide for young girls in need.

Convention took a brief break, to come back for workshops on the Bishop Search Committee and A Day in the Life of the Bishop, Western Kansas style! Bishop Milliken announced the evening festivities would take place there in the Museum, cash bar would open at 6 p.m. and dinner would follow. He also mentioned the ECW again had baskets to bid on and they will be drawn for and given away at the dinner this evening.

WORKSHOPS

Carolyn Peterson, Chairperson for the Search Committee was called on to explain some of the goings on in the search process for a new bishop for this diocese. Then Bishop Milliken will give the attendees an overview of what goes on in the Bishop's office.

THE SEARCH COMMITTEE

Ms. Peterson explained the Search Committee was appointed by the Standing Committee of this diocese and she was appointed Chair of the group. She then introduced the members of the Committee: The Revs. Don Martin, John Seatvet, Bill Waln, Amy Long and Karen Lemon, Mr. Steve Molstad, Mrs. Georgia Briery, Mrs. Lisa Hodges and Mr. Bill Roenbaugh are those who are here at Convention. She explained a timeline was established, a profile was compiled and placed online with cut off dates, etc., for those interested in the position of Bishop of Western Kansas. After names are submitted, the Search Committee will read all available materials about the individual, a telephone interview will take place and the Committee will meet to determine names to be submitted to the diocese for consideration. The walk-about will take place in the third week of April 2018, so that all in western Kansas will have an opportunity to meet the nominees. Election of our new bishop will take place in May and the Consecration date has been set as Saturday, December 1, 2018 with the National Church Office, and Presiding Bishop Curry will be here for the Consecration.

Ms. Peterson then asked each member of the Committee to share a bit of their reflections regarding this process. Several questions were proposed from the group gathered and hopefully everyone felt their question was answered to their satisfaction.

DAY IN THE LIFE OF THE BISHOP

Let me begin by reading what the Book of Common Prayer says bishops do, this is from the Ordination and Consecration service:" a bishop is called to be one with the apostles on proclaiming Christ's resurrection and interpreting the Gospel; to guard the faith, unity and discipline of the Church; to celebrate and to provide the administration of the sacraments; to ordain priests and deacons and to join in ordaining bishops; and to be in all things a faithful pastor and wholesome example for the entire flock of Christ, be faithful in prayer and in the study of Holy Scripture, boldly proclaim and interpret the Gospel of Christ, enlightening the minds and stirring up the conscience of your people. Be merciful to all, show compassion to the poor and strangers, and defend those who have no helper?" This is basically what the Prayer Book says, and I have a page and a half of Canons, plus Letters Dimissory, appointment of assisting Bishops, assign mentor or priest, authorize ecclesiastical authority in extended absences, disagreements effecting pastoral relationships and dealing with those pastoral relationships. Preside at worship during parish visits, perform official acts as needed." There are many more listed, some important and many not so important, but we haven't been able to get them out of the Prayer Book.

A couple of things Carolyn brought up. We talked about May as Election for our next bishop. Since July 2018 is General Convention in Austin and one of the quirky Canons we have says we cannot have a bishop's election within thirty (30) days of General Convention. The July Convention backs us up to May. Years ago, you could have convention and the person elected could/would be approved at General Convention. That now has gone away. We are a bit under the gun, because at some point when I decided I needed to retire, the National Church helped with that, because there is an age limit. I wrote the Presiding Bishop's office to say we wanted to get on the list for a Consecration, and they quickly wrote back and said 'okay, we can do that on December 1, 2018'! I wrote back and explained we weren't thinking that soon and they said, 'take it or leave it'!!

Now I must get with the other Chancellors at the National Office and say, if we have a Consecration on December 1, 2018, for a new Diocesan, and it was my intention to retire on December 31, 2018 of the same year, what do I do for those thirty days? Again, this is one of those oddities of the Canons. We could elect a Coadjutor, but that takes permission of the Church and then what am I going to do for those thirty days? I don't know, just stay around and make it miserable for the next person.

Several members of Convention spoke regarding the upcoming election, the current Bishop and what he has meant to us here in Western Kansas.

The Budget and Finance hearing will meet outside of this room as soon as we adjourn here this afternoon. Be sure to take your papers with you because they will set up in here for the banquet. Thank you.

2ND BUSINESS SESSION SATURDAY, OCTOBER 21ST

Bishop Milliken called the second business session to order and announced it was time for elections. We have to have a vote on Clergy nominees for Diocesan Council since there are two three-year terms, and one one-year term. There also will be a vote in the Lay order; there are two positions open and three nominees.

Ballots were distributed and will be collected and counted by the tellers.

While tellers are counting, I'll make a couple of announcements. There are still prayer shawls available in the display area and they are for the taking.

The ECW baskets net a total of \$746.00 last night. Thank you!

It was moved and seconded to receive all written reports by title. CARRIED

Patty Wamsley, Directress of Daughters of the King spoke about their organization and information available in the exhibit area, They have bookmarks to give you and there are prayer shawls available. There are specific orders we take, for prayer, service and evangelism. I have the forms at the table.

One of the youth representatives asked the delegates for Keratos for those attending the upcoming Happening. We are asking you to write some words of love for those attending the November Happening. We will pick these up and copy them for those attendees.

We have election results as follows: Lay order: Nan Pyle and Carolyn Peterson Clergy order: The Rev. Georgia Decker and The Rev. Harvey Hillin for three- year terms and The Rev. Charles Kerschen for the one- year term.

FINANCIAL REPORT OF THE DIOCESE

Dr. Mike Wamsley, Diocesan Treasurer, presented the Financial Report of the Diocese by title.

ADOPTION OF THE BUDGET AND SETTING OF THE ASSESSMENT

Dr. Wamsley stated that there were no changes to the budget as presented yesterday as a result of the budget hearing. He reminded the Convention that the key to the budget is receipt of payments by the congregations. He **moved** the adoption of the 2018 budget. **Seconded**, **adopted**.

He then **moved** that the Diocesan assessment for 2018 be 15% of congregational net disposable income. **Seconded**, **adopted**.

REPORT OF THE DIOCESAN ENDOWMENT FUND

Mr. Larry Williams reported for the Diocesan Endowment Fund. At last year's 12/31/16 which is almost a year old, the Fund amounted to \$3, 060 million dollars and this week, which is mid-October, 2017, the fund stands at \$3.3 million dollars. It has served as a good backstop for the diocese and we are thankful for Mike Beatty's help. The other longtime members of the Fund committee have, for various reasons not been participants this year.

Treasurers Report

The past year has been a great year from a financial viewpoint. I see no reason that the next year should be any different. Thanks to the B&F Committee, Bishop Milliken, Mrs. Toni Cottrell, Mrs. Carolyn Peterson, Mrs. Pam Smith, a budget for 2018 has been developed and is actually a few dollars less than the 2017 counterpart. I would like to thank all these people for making my job an easy one. I would imagine that there are very few budgets in this day and age that actually decrease from previous years. Elsewhere in this packet you will find a detailed summary of the budget which has already been approved by Diocesan Council, and which will be presented to Delegates for approval. There also will be, as usual, an opportunity for questions and discussion during the business meeting.

ENDOWMENT FUND TRUSTEES' REPORT

2017 Report of Activities

The investment performance of the Endowment Fund was well above average this year, gaining about 18% on invested assets. We try to outperform the Standard & Poor's 500 average - including dividends, which the gained 12% for 2016. The Fund has outperformed the S&P 8 times in the last 20 years. During the last 13 years, since 1996 when the fund had investments totaling \$636,000, \$1,842,631 has been contributed and \$1,577,748 has been distributed to various beneficiaries. During this period, we have had three significant bear markets. The Endowment Fund now has assets of \$3,334,004 as compared to \$1,936,801 as of December 31, 2007, before the last financial bubble burst.

This year, we purchased more shares of Emerson and Starbucks and added Apple and Kroger to our holdings. We sold shares of Caterpillar and our entire holding of Coca Cola. Apple (up 60%), Caterpillar (up 41%), Union Pacific (up 36%) and Suncor (up 30%) were the largest gainers this year but nine of the sixteen stocks we hold did better than the S&P. The weighted average Price / Earnings Ratio for the portfolio was 25, slightly higher than the average for the S&P 500 of 22. Page 4 shows the details of the current investments.

The Endowment distributed \$137,087 to the Diocese, \$50,000 to Ashby House, \$40,000 to St. Anne's, \$10,065 to Holy Apostles, \$3,500 to Incarnation and \$1,146 to St Mark's. See page 3. The churches in Bennington and Meade were closed and the funds balances for those churches were transferred to the Mission Opportunity Fund.

ENDOWMENT FUND TRUSTEES' REPORT (cont)

The investment gain for the year of \$562,378 was allocated proportionally among 14 funds based on the 2016 average balance for each. Five percent of the average three-year balance for each Permanently Restricted Fund was transferred to its corresponding Spendable Fund, providing \$87,961 new money for use by these beneficiaries in future years. Page 5 shows these calculations. These spendable funds now total \$599,112.

Spendable Funds are available for withdrawal, subject to these guidelines:

- The Altar Guild Fund balance is \$4,391 and is to be used to benefit the Diocesan Altar Guild.
- The Holy Apostles Fund balance is \$11.546 and is to be used to benefit that church.
- The Incarnation Fund balance is \$3,053 and is to be used to benefit that church.
- The St. Anne's Fund balance is \$48,061 and is to be used to benefit that church
- The Undesignated Fund balance is \$532,061 and is to be used for any purpose the Bishop and Council select.

Managed Funds may be withdrawn in part or in total by the donor. Partial withdrawals are permitted upon the request of the donor or on a regularly scheduled monthly or quarterly basis. Withdrawals of entire fund balances may be made with at least 30 days' written notice to the trustees.

Council Restricted Funds may be withdrawn by the Diocese, subject to these guidelines:

- The Future Ministry Opportunity Fund balance is \$252,034 and is to be used at the discretion of the Bishop and Council
- The Lambeth Fund balance is \$17,069 and is to be used to help fund the Bishop's travel expenses to the Lambeth Conference.
- The Standing Committee Fund balance is \$2,489 and is to be used at the discretion of the Bishop and Council

The financial statements of The Diocese of Western Kansas at September 30, 2017 are for the period January 1, 2017 through September 30, 2017 and are unaudited. The assessment income represents income received for the period January 1, 2017 through September 30, 2017 and reflects September assessments received through October 13, 2017. Expenses incurred are for the period January 1, 2017 through September 30, 2017. The financial statements that will appear in the 2016 Journal of the Diocese will be audited as of October 16, 2017.

The audited assets and liabilities of the Endowment Fund represent balances as of December 31, 2016. The audited Endowment Fund statement of assets, liabilities and fund balances are incorporated into the financial statement of the Diocese of Western Kansas at year end and will appear in the 2016 Journal of the Diocese of Western Kansas.

2016 Audit Report

An Independent Certified Accountant, Roger Field CPA from the firm Lindburg Vogel Pierce Faris, Hutchinson, Kansas, performed the 2015 Audit of accounting and financials for the Diocese of Western Kansas. It was completed in September of 2017. The Audit report and financial reports for year end 2016 are available in the Diocesan office for anyone in the Diocese to review.
